O R D E R

1. This petition is filed under Section 25 of the Code of Civil Procedure seeking transfer of the proceedings, bearing HMA No. 1148/2024, titled as "*Nitish Kumar Vs. Kavita*", pending before the Court of the learned Principal Judge, Family Court, North District, Rohini Courts, Delhi, to the Court of the learned Principal Judge, Family Court, Jhajjar, Haryana.

2. The grounds raised by the petitioner for seeking the transfer are: she has no source of income and is completely dependent on her parents, who are senior citizens; she is unable to effectively defend the proceedings initiated by the respondent at Rohini Courts, Delhi.

3. On such consideration, we are of the view that the transfer can be allowed. Consequently, the Transfer Petition is allowed.

4. Accordingly, the proceedings in HMA No. 1148/2024, titled as "*Nitish Kumar Vs. Kavita*", pending before the Court of the learned Principal Judge, Family Court, North District, Rohini Courts, Delhi is transferred to the learned

Principal Judge, Family Court, Jhajjar, Haryana.

5. The Transferor Court shall transfer the records pertaining to the said case to the transferee court, as expeditiously as possible.

6. Parties are directed to appear before the concerned Court on 18.05.2026.

7. The Respondent-husband is permitted to attend the proceedings virtually, unless his presence is required by the trial Court.

8. Pending application(s), if any, shall stand disposed of.
